When you visit a childcare program remember these three things:

- LOOK –take the time to look over the facility, both inside and outside
- CHECK –to be sure that the practices important to you, such as education, health, and safety are used in the child care program
- ASK –question the childcare provider, teachers, and/or director as well as other parents; don't be afraid to ask the program for references
